Terms of membership of the Third Age Trust

As a nominated representative of my u3a, I agree to:

- adhere to the principles of the u3a movement (available at u3a.org.uk).
- operate in accordance with our written constitution, which must follow the model constitution, provided by the Trust and agreed with the regulatory authorities. Any amendments to the model, at any time, must be cleared in advance with the Third Age Trust, prior to its presentation to our members at a General Meeting.

- send a copy of our constitution to the u3a Office, once it has been accepted by our members at the first AGM and subsequently whenever amendments have been agreed.
- abide by the legal requirements and recommendations of the Charity Commission in England and Wales, the Office of the Scottish Charity Regulator and the Northern Ireland Charity Commission as applicable.
- pay the stated membership subscription.
- accept the Articles of Association of the Third Age Trust (available at u3a.org.uk), and act in accordance with them and any resolution passed at a General Meeting of the Third Age Trust.
- complete an Annual Return and provide other details to the u3a Office as may be requested from time to time. We will provide at least one telephone number for membership enquiries to the u3a Office.
- conform to the rules regarding the use of the u3a name and logo which are registered trademarks and must only be used with the permission of the Third Age Trust.
- encourage and assist in every way possible, the formation of new u3as in neighbouring areas.
- inform the Trust if we are struggling to cope with the demand for membership within our local community, so that steps can be taken to ensure u3a membership is available to all third agers who want it.
